# WE'RE READY FOR STORM SEASON. ARE YOU?

Now that summer is in full swing; I welcome more opportunities to be outdoors and enjoy the warmer weather like many of you. Summertime brings many of my favorite activities like ball games (Go Cubs!), cooking out with family and friends, afternoons on the water, seeing the crops grow, and countless other things.

But summer months also make conditions suitable for dangerous storms. These potential weather events can cause destruction to our electrical system. Still, I want you to know that Allamakee-Clayton Electric Cooperative crews are ready and standing by to respond should power outages occur in our area.

When significant storms knock out power, our line crews take all necessary precautions before they get to work on any downed lines. I would encourage you also to practice safety and preparedness to protect your family during major storms and outages.

The Federal Emergency Management Agency recommends the items below as a starting point for storm and disaster preparedness, but you can visit **www.ready.gov** for additional resources.

- Stock your pantry with a three-day supply of non-perishable food, such as canned goods, energy bars, peanut butter, powdered milk, instant coffee, water, and other essentials (i.e., diapers and toiletries).
- Confirm that you have adequate sanitation and hygiene supplies, including towelettes, soap, and hand sanitizer.
- Ensure your First Aid kit is stocked with pain relievers, bandages, and other medical essentials, and make sure your prescriptions are current.
- Set aside essential household items you will need, including flashlights, batteries, a manual can opener, and a portable, battery-powered radio or TV.
- Organize emergency supplies, so they are easily accessible in one location.


In the event of a prolonged power outage, turn off major appliances, TVs, computers, and other sensitive electronics. These actions will help avert damage from a power surge and help prevent overloading the circuits during power restoration. That said, *do leave one light on so you will know when power is restored*. If you plan to use a small generator, make sure it is rated to handle the energy you will need, and always review the manufacturer's instructions to operate it safely.

Listen to local news or a NOAA Weather Radio for storm and emergency information, and check ACEC's website for power restoration updates. **480** 

After the storm, avoid downed power lines and walking through flooded areas where power lines could be submerged. Allow ample room for utility crews to perform their jobs, including on your property, safely.

I hope we do not experience severe storms this summer, but we can never predict Mother Nature's plans. At Allamakee-Clayton Electric, we recommend that you act today because there is power in planning. From our co-op family to yours, we hope you have a safe and wonderful summer.

### GRASSLEY RECEIVES NRECA'S DISTINGUISHED SERVICE AWARD

Ahead of NRECA's Legislative Conference last month, Sen. Chuck Grassley was presented with NRECA's Distinguished Service Award, which recognizes a lawmaker's outstanding contribution to the progress of electric cooperatives and the public power program in the United States.

Grassley was recognized for his unwavering support for America's electric cooperatives throughout his six decades of public service, including his hometown co-op, Butler County REC. He played a leading role in advancing key electric co-op policy priorities, including enactment in 2019 of the RURAL Act, which saved co-ops from losing their tax-exempt status if

they received government grants surpassing 15% of their nonmember income. This legislation saved electric co-ops millions of dollars in federal taxes that now go directly toward serving co-op consumer-members.

Grassley also championed legislation to repeal the "Cadillac Tax" imposed on health care benefits that cooperatives provide for their employees. NRECA estimated that its member cooperatives would save more than \$30 million a year in

pension insurance premiums because of this legislation.

"Butler County REC is proud to be Sen. Grassley's hometown cooperative," said Craig Codner, the co-op's CEO. "We appreciate his advocacy for cooperatives. ## RUSTIC CHIC EVENT CENTER "IT'S ALL ABOUT FAMILY"

Over 15 years ago, 2 best friends dreamt up the crazy idea to have the best wedding and event center in Northeast Iowa. Their journey finally began in March of 2020. They started by renovating an 80-year-old, 5500 sq. foot barn from the ground up.

Audrey Gibbs and Connie Reierson have been friends for 20 years. Both have raised families and have their own professions. Audrey is a massage therapist, Connie farms. With the drop in family commitments and both wanting to have a little more "me" time, they started looking for some type of project that could be a joint effort, and maybe eventually even be something lucrative. They started to throw ideas at one another.

Audrey was searching her brain to come up with something, then her gaze fixed on the wooden barn sitting in front of her house. For some reason, the thought of barn dances came to her... then dances are usually held as celebration, celebration as in wedding. Suddenly they had their idea.

"Both of us have always been into weddings. I make silk flowers for people for decorations and we've both got other decorations we've collected over the years," Audrey said.

The idea caught Connie's imagination as well. She has been someone who's learned lots of different skills over the years as she helped manage a working farm.

It also helped that Audrey's daughter, Jessica, was already making plans for a future wedding to Jamie Hummel.

The two flew into the old barn with hammers and saws in hand. They called in a structural engineer to make the sure the barn which had a 1941 date branded into one of the support beams, could be made safe for human inhabitance. The engineer did find a split in one of the wooden beams that had to be filled. The two then started sanding



all of the cedar beams in the upper level down for a natural look. The oak beams in the lower level were also ground and sanded down but this was an even more labor-intensive job because hogs that were once housed there had chewed around the beams bases, making some uneven surfaces.

They purchased pine boards to line the walls. "We sanded and stained every board," Connie related.

Despite the work, the two could see this was going to be a project that would really give them a sense of pride and accomplishment.

"It was fun, we enjoyed each step," Connie said.

"Little by little we took out all of the stalls and calf pens," Audrey added.

D&H Construction came in and helped with some of the remodeling work. Holthaus Electric of Festina did the electrical work. Sewer and water were installed.

Four hours before that wedding, the pair realized that they were missing a door.

"We just ripped a door off in my house and put it there," Audrey said. Her house is only a few feet away from the barn. Both are located north of West Union on the west side of Highway 150. Audrey's house has the distinction of being constructed for an episode of the Extreme Makeover television show.

Only doing weddings and no receptions, they hosted two ceremonies last fall.

Those were both held in the lower level while things progressed on the top floor, including the installation of a large cathedral window on the south wall.


"Covid actually worked with us instead of against us because everything was smaller," Audrey said.

With both levels being assessable the venue has a capacity of 200.

Their first wedding reception of the year was held on March 6, 2021, for none other than Audrey's daughter, Jessica.


#### Energy Efficiency Tip of the Month

#### BARBACOA BEEF

Toppings:

Cheddar cheese

Sour cream

Guacamole

Black beans

Corn chips

Rice

Lettuce

Salsa

- 2<sup>1</sup>/<sub>2</sub> 3 lb. chuck roast beef
- 1 onion, cut into chunks
- 1-3 canned chipotle peppers in adobo sauce
- 4-6 garlic cloves, minced
- 2-3 T. lime juice
- 3 T. apple cider vinegar
- <sup>3</sup>⁄<sub>4</sub> c. water or beef broth
- 1 T. ground cumin
- 2 tsp. dried oregano
- 1½ tsp. salt
- 1 tsp. black pepper

Place beef in crockpot. Put remaining ingredients in blender and blend well. Pour over beef. Cover and cook on low 7-8 hours. Pull beef apart before serving. Serve like haystacks with desired toppings.

## PLANNING A YARD PROJECT? DON'T JUST DIG IN

A s we're beautifying our yards this spring, we shouldn't just dig in. According to 811, the "Call Before You Dig" national hotline, an underground utility is damaged every nine minutes because someone didn't call before digging.

Whether it is a do-it-yourself project or you are hiring a professional, contact Iowa One Call by dialing 811 at least 48 hours (not including weekends and holidays) before starting any digging project to request that all underground utilities be marked. The service is free. **4076** 

You may think it won't hurt anything to dig in an unmarked yard when landscaping, installing a fence, deck or mailbox, or even "just" planting a small flower bed or bush, but damaging an underground cable can have serious consequences.

Hitting a line could result in severe injuries and disrupted service for you and your neighbors. It could also make a dent in your wallet for repair fees or other fines.

The 811 hotline points out that there is more than one football field's length of buried utilities for every man, woman, and child in the U.S.



### **BEFORE DIGGING**

- Call 811 at least 48 hours before starting any digging project.
- Wait the required amount of time for affected utility operators to respond to your request.
- Confirm that all affected utility operators have responded to your request and marked underground utilities.



• Dig carefully around the marks with care.

Remember that location flaggers will NOT mark privately-owned underground lines. Examples of private lines/equipment include well and septic, underground sprinkler systems, invisible fencing, gas, or electric lines that serve a detached building, as well as any lines (electric, water, sewer) from the meter to your home.

#### FIND YOUR SERVICE NUMBER

Three *Service Location* numbers are hidden within the text of this newsletter. The numbers are from three different



regions of our service area – all three are worth a **\$10 bill credit** if found. To claim the credit, the number must be yours and you need to notify us when you find it.
