We also offer energy efficiency programs to save you money and energy.



You can find information about DIY Energy Audits on our website; we frequently run energy savings tips in this newsletter, bill insert, and social media platforms. Finally, our member services manager is available for any energy efficiency questions you may have.

Our Board of Directors approved the Operation RoundUp program this year. Members can opt to "round up" their energy bills to the next whole dollar amount, and these extra pennies can help others right here in our community. You will receive more information about this program in the coming months, and it will take some time to build up this program, but we look forward to all we can offer our local communities through your generosity!

You may have noticed our electric vehicle (EV) out in our service area. We invested in an EV to promote a greater understanding of electric vehicles and promote their use, especially given the focus on electrification of the transportation sector. Members over 18 can sign up to take it for a test drive!

But the most important investment we make is in our local youth. ACEC has numerous staff who volunteer to youth clubs and programs and serve in a volunteer role to community fire departments and emergency services. In addition, the Cooperative has provided \$18,800 in scholarships to local students since the establishment of the Hauschild Scholarship Fund in 1995. In addition, each year, through our Youth Tour program, we send high school sophomores and juniors to Washington, D.C., for a week-long immersion to experience democracy in action. Next year will be an exciting trip for our youth as Youth Tour returns after a two-year interruption due to the pandemic.

At the heart of all of these programs is you—the members we proudly serve. Looking back, I'm grateful for so many incredible community partners and for the positive impact we can continue to make. While the larger environment in which we operate is constantly changing, one thing remains constant. Working together, we'll continue to be a catalyst for good.

# PLUGGED IN Electrical Vehicle Update

Get Charged: Electric Trucks and SUVs are Coming

Tesla is expected to make the Cybertruck available by early 2022.

- The upfront cost of an EV purchase is now more competitive with similar internal combustion models, and most EVs qualify for a federal tax credit of up to \$7,500.
- The cheaper operating fuel cost per mile (for electricity) compared to gasoline or diesel is another attractive feature for drivers.

Ford's electric F150 Lightning is scheduled to arrive in spring 2022, starting under \$40,000 for the commercial trim package (230-mile range model). A 300+ mile battery is an option, and all models are 4X4 with respectable towing and payload capacities. The Lightning is also equipped to provide 9.6kW of home backup power or portable power for a job site.

Tesla has more than a million pre-orders for their new Cybertruck, which will likely arrive in 2022. The 250-mile range 2WD model starts under \$40,000 and steps up to \$50,000 for the 300-mile range 4WD model. Tesla plans to offer a 500+ mile range version for \$70,000 that can tow more than 14,000 pounds.

GMC has announced a late 2021 release of an electric Hummer with 1,000 horsepower and additional features for off-road performance.

Rivian, a startup backed by billions of dollars from Ford and Amazon, is planning to unveil their R1T electric pickup later this year.

Crossover SUVs (CUVs) are one of the most popular types of vehicles, and a number of manufacturers say they'll have electric models available soon. Ford's Mustang Mach-E is actually available now with a range up to 305 miles, starting at \$45,000. Volkswagen's ID4 CUV starts at \$40,000 and is available with AWD options. More electric SUVs are coming, including Rivian's R1S, Nissan's Ariya and Volkswagen's six-passenger ID6.

And it's not just vehicles that are shifting to electric. Electric snow



machines and jet skis are arriving soon. Even large construction equipment like excavators, backhoes and heavy-duty trucks will have electrically fueled models.

The remaining hurdle for increased EV adoption in rural areas is fast, sufficient charging for longer trips. Most EV owners charge at home, but more fast-charge stations on rural highways will be helpful.

If you're interested in an EV, talk to your electric co-op. They may offer special EV rates or rebates. ■


## ACEC RETURNS NEARLY \$600,000 TO MEMBERS

Allamakee-Electric Cooperative is always looking into new products and offerings that could benefit our members. Many homeowners believe their utility companies or homeowners insurance is responsible for emergency repairs to the water, sewer, plumbing, electrical, and heating and cooling systems. The reality is that in many cases, the homeowner is responsible for these repairs.

ACEC has recently partnered with HomeServe, an independent company of ACEC that offers optional service plans to provide home repair plans to help eligible members be prepared and have the best possible service in the case of an emergency. In addition, HomeServe has contracted with our **LOCAL, licensed, and insured technicians** to perform covered repairs, which guarantee against defects in materials and workmanship for one year.

## A FEW THINGS TO CONSIDER

- Direct all payment and coverage questions to HomeServe.
- If you want HomeServe to list you as a contractor, do not hesitate to contact HomeServe directly or ACEC to submit the required information.

- Allamakee-Clayton intends to offer future plans that include coverage for water heaters, furnaces, air-source heat pumps, electrical surge, interior electric, exterior electric, and air conditioners.
- Any member who wants to have their name removed from HomeServe's mailing list should contact HomeServe directly or Allamakee-Clayton Electric Cooperative.
- Most plans start 30 days after HomeServe processes your order. You can make a service call immediately after your plan starts. During the initial 30-day waiting period, you will receive the Terms and Conditions to help you decide if coverage is right for you. You may cancel within 30 days of your start date for a full refund, less any claims paid, where applicable.

## ROLINDA ACRES HONORED WITH IADG VENTURE AWARD

The Iowa Area Development Group (IADG), on behalf of Iowa's rural electric cooperatives, municipal utilities, and independent telecommunications companies, honored eight distinguished Iowa companies and leaders with the Iowa Venture Award this year.



**ROLINDA ACRES**, owned by Tara and Pat Reisinger, is located near the northeast Iowa town of Waterville. The Reisingers have five hog buildings, farm 1,500 acres, milk 785 cows and operate a dog breeding business. In 2001, the Reisingers milked 150 cows. Today, that number has climbed to 785 cows, with plans to nearly double in 2023. To grow their herd and shorten their workdays, they constructed a 96,000-square-foot barn housing eight robotic milkers in 2020. Approximately 550 cows are robotically milked, while they milk 260 in the existing parlor.

Rolinda Acres plans to add another building and eight additional robotic milkers by 2023. *See the Co-op's Dec. 2 Facebook post to watch a video on Rolinda Acres, including an interview with the owners and ACEC's general manager.*

The Iowa Area Economic Development provides business and community project support on behalf of nearly 250 Iowa electric and telecommunications utilities. Confidential services include available site and building identification, financial incentives, technical assistance, and resources necessary to meet the client's specific needs. IADG established the Iowa Venture Award in 1988. Over the past three decades, IADG has recognized 280 organizations for their significant contributions to Iowa's economy through entrepreneurial leadership, innovation, and the creation of job opportunities. ■



# MEMBER SOUP RECIPES

## VEGETABLE CHEESE SOUP

- 1 c. celery, finely chopped
- ½ c. carrots, finely chopped
- ¼ c. onion, finely chopped
- 1 qt. chicken broth
- 1 qt. milk
- 1 lb. Velveeta cheese
- ½ c. butter
- ½ c. flour
- ½ tsp. dry mustard

Cook celery, carrots, onion, and chicken broth until vegetables are tender. Scald milk; add Velveeta, stir until melted. In a saucepan, melt butter, flour, and mustard. Mix well; stir in hot vegetables, and broth.

“My favorite thing about this soup is as long as I have plenty of celery, carrots and onion on hand, I can cook another batch of vegetables and broth, cool and freeze. The next time I want to make this soup, just thaw and heat and continue the rest of the recipe – You have soup made quickly with no mess.”

## CORN CHEESE CHOWDER

- 6 slices bacon, diced OR 1 c. ham, cubed
- 1 sm. onion, chopped
- 3 T. flour
- 2 c. water
- 1 c. raw potato, diced
- ¼ t. dry sage
- 1 lg. bay leaf
- 1 c. boiling water
- 1 ½ c. cheddar cheese, grated
- 2 c. fresh cooked or canned whole kernel corn
- 1 tsp. salt
- 1 1/8 tsp. pepper
- 1 c. powdered coffee creamer

Combine bacon and onion in a large saucepan. Cook until bacon is browned and onion is tender. Blend in flour (if you use ham, you may have to add a little water to replace bacon fat); cook one minute, mixing the flour in thoroughly. Add water, potatoes, sage, and bay leaf. Cover and cook until potatoes are just tender, about 10 to 15 min. Remove bay leaf; add coffee creamer, BOILING water, grated cheese, corn, and seasonings.

Heat until soup comes to a boil and cheese melts. Sprinkle with chopped parsley and chives if desired. Serves 5 to 6.

## MOM'S CHICKEN SOUP

- 1, 3-4 lb. chicken, cut up
- 4 quarts water
- 3 carrots, sliced into chunks
- 3 celery stalks, sliced into chunks
- 3 onions, sliced into chunks
- 1 tsp. salt
- ½ tsp. pepper
- Chicken base or bouillon cubes, to taste
- Egg noodles, optional

Rinse chicken under cold water. Put everything but the chicken base or bouillon cubes in a pot. Bring to boil. Reduce heat to low and simmer 1 – 1 ½ hours until chicken falls off the bone; cool slightly. Remove bone and return chicken to soup. Add chicken base or bouillon cubes, if desired, and stir until dissolved.
